RESOLUTION 2019-04

A RESOLUTION OF THE BOARD OF SUPERVISORS OF UNIVERSITY PARK RECREATION DISTRICT RATIFYING THE ACTIONS OF THE DISTRICT MANAGER IN RE-SCHEDULING AND RE-NOTICING THE PUBLIC HEARING ON THE PROPOSED BUDGET FOR FISCAL YEAR 2018/2019; AMENDING RESOLUTION 2018-09 TO SET THE PUBLIC HEARING THEREON; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the University Park Recreation District ("District") is a local unit of special-purpose government established pursuant to the Chapter 2017-220, Laws of Florida, for the purpose of planning, financing, constructing, operating and/or maintaining certain infrastructure improvements; and

WHEREAS, on September 26, 2018, at a duly noticed public meeting, the District's Board of Supervisors ("Board") adopted Resolution 2018-09, approving the proposed budget for Fiscal Year 2018-2019 and setting a public hearing on the proposed budget for November 9, 2018 at 2:00 p.m. at the University Park Country Club's Lakeside Room, 7671 The Park Blvd, University Park, FL 34201; and

WHEREAS, in order to comply with Florida Statute notice requirements, the Board was required to move the public hearing from November 9, 2018 to a later date; and

WHEREAS, the District Manager, at the direction of the Chairman of the Board of Supervisors, rescheduled the date and time of the public hearing to December 14, 2018 at 2:00 pm a.m., at the same location as provided in Resolution 2018-09 and caused notice thereof to be provided pursuant to Florida law.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE UNIVERSITY PARK RECREATION DISTRICT;

SECTION 1. Resolution 2018-09 is hereby amended to reflect the changed date and time of the public hearing on the proposed budget for Fiscal Year 2018/2019 from November 9, 2018 at 2:00 p.m. to December 14, 2018 at 2:00 p.m.

SECTION 2. The actions of the District Manager in re-scheduling and re-noticing the public hearings are hereby ratified and approved.

SECTION 3. Except as otherwise provided herein, all of the provisions of Resolution 2018-09 continue in full force and effect.

SECTION 4. The invalidity or unenforceability of any one or more provisions of this Resolution shall not affect the validity or enforceability of the remaining portions of this Resolution, or any part thereof.

SECTION 5. This Resolution shall take effect upon its passage and adoption by the Board.
