RESOLUTION 2019-28

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE UNIVERSITY PARK RECREATION DISTRICT SETTING A PUBLIC HEARING TO BE HELD ON JUNE 14, 2019, AT 1:00 P.M. OR AS SOON THEREAFTER AS SAME MAY BE HEARD AT UNIVERSITY PARK COUNTRY CLUB'S LAKESIDE ROOM, 7671 THE PARK BLVD, UNIVERSITY PARK, FL 34201, FOR THE PURPOSE OF HEARING PUBLIC COMMENT ON IMPOSING A SPECIAL ASSESSMENT ON CERTAIN PROPERTY WITHIN THE DISTRICT GENERALLY DESCRIBED AS THE UNIVERSITY PARK RECREATION DISTRICT IN ACCORDANCE WITH MANATEE COUNTY ORDINANCE 18-29.

WHEREAS, the Board of Supervisors of the University Park Recreation District, ("Board") has previously adopted Resolution 2019-27, entitled:

A RESOLUTION OF THE UNIVERSITY PARK RECREATION DISTRICT DECLARING SPECIAL ASSESSMENTS; INDICATING THE NATURE AND ESTIMATED COST OF THOSE EXPENSES WHOSE COST IS TO BE DEFRAYED BY THE SPECIAL ASSESSMENTS; PROVIDING THE PORTION OF THE ESTIMATED COST OF THE OPERATION AND MAINTENANCE OF THE DISTRICT TO BE DEFRAYED BY THE SPECIAL ASSESSMENTS; PROVIDING THE MANNER IN WHICH SUCH SPECIAL ASSESSMENTS SHALL BE MADE; PROVIDING WHEN SUCH SPECIAL ASSESSMENTS SHALL BE MADE; DESIGNATING LANDS UPON WHICH THE SPECIAL ASSESSMENTS SHALL BE LEVIED; PROVIDING FOR AN ASSESSMENT PLAT; ADOPTING A PRELIMINARY ASSESSMENT ROLL; PROVIDING FOR PUBLICATION OF THIS RESOLUTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in accordance with Resolution 2019-27, a preliminary assessment roll has been prepared and all other conditions precedent set forth in Chapter 170, *Florida Statutes*, and Manatee County Ordinance 18-29, to the holding of the aforementioned public hearing have been satisfied, and the roll and related documents are available for public inspection at 12051 Corporate Boulevard, Orlando FL 32817 ("District Records Office").

**NOW THEREFORE BE IT RESOLVED BY THE BOARD OF
SUPERVISORS OF THE UNIVERSITY PARK
RECREATION DISTRICT:**

1. There is hereby declared a public hearing to be held at 1:00 p.m., or as soon thereafter as may be heard, on June 14, 2019 at University Park Country Club's Lakeside Room, 7671 The Park Blvd, University Park, FL 34201, for the purpose of hearing comment and objections to the proposed special assessment program for community improvements within the District, as identified in the preliminary assessment roll, a copy of which is on file. Affected parties may appear at that hearing or submit their comments in writing prior to the meeting to the office of the District Manager, 12051 Corporate Boulevard, Orlando, Florida 32817.

2. Notice of said hearing shall be advertised in accordance with Chapters 170 and 197, *Florida Statutes*, and Manatee County Ordinance 18-29, and the District Manager is hereby authorized and directed to place said notice in newspapers of general circulation within Manatee County (by two publications one week apart with the first publication at least 20 days prior to the date of the hearing established herein). The District Manager shall file a publisher's affidavit with the District Secretary verifying such publication of notice. The District Manager is further authorized and directed to give (30) thirty days written notice by mail of the time and place of this hearing to the owners of all property to be assessed and include in such notice the amount of the assessment for each such property owner, a description of the areas to be improved and notice that information concerning all assessments may be ascertained at the District Office. The District Manager shall file proof of such mailing by affidavit with the District Secretary.


3. This Resolution shall become effective upon its passage.
