Mr. Heitzner noted that Sunday Brunch has declined this summer due to low attendance and the team requests a transition to offer Sunday Brunch every other week. The members discussed it and agreed it was best and will be reevaluated in August.

RESOLUTION 2026-22

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE UNIVERSITY PARK RECREATION DISTRICT PROVIDING FOR A PORTION OF THE ESTIMATED COST OF THE CONSTRUCTION, RECONSTRUCTION, RENOVATION, ENLARGEMENT, EXTENSION, EQUIPPING, AND/OR MAINTENANCE OF RECREATIONAL FACILITIES BY THE UNIVERSITY PARK RECREATION DISTRICT TO BE DEFRAIDED BY NON-AD VALOREM SPECIAL ASSESSMENTS; PROVIDING FOR A FINAL ASSESSMENT PLAT; ADOPTING A FINAL ASSESSMENT ROLL; PLACEMENT OF ASSESSMENTS IN AN IMPROVEMENT LIEN BOOK; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the University Park Recreation District ("District") is a local unit of special-purpose government located in Manatee County, and established pursuant to Manatee County Ordinance No. 18-29, as amended by Ordinance No. 23-95 ("Ordinance") for the purposes of constructing, installing, acquiring, operating and/or maintaining public recreational infrastructure improvements; and

WHEREAS, the Board of Supervisors (the "Board") of the District hereby determines to undertake, to purchase, construct, reconstruct, renovate, enlarge or extend, equip, acquire, operate and/or maintain recreational facilities within the University Park Recreation District, described in Exhibit "A" and incorporated herein by referenced; and

WHEREAS, it is in the best interest of the District to purchase, construct, reconstruct, renovate, enlarge or extend, equip, acquire, operate and/or maintain recreational facilities by issuing bonds secured by special assessments levied on benefitted lands within the District (hereinafter, the "Assessments"); and

WHEREAS, the District is empowered by the Ordinance and Chapters 170, 197 and 418, Florida Statutes, to finance, fund, plan, operate and maintain the District and to impose, levy and collect the Assessments; and

WHEREAS, on November 3, 2023 the Board adopted Resolution 2024-02 declaring special assessments and on December 8, 2023, the Board held an equalization hearing and adopted Resolutions 2024-06 and 2024-07 confirming a final assessment roll to secure a \$20,600,000 bond issuance (originally, the "Series 2024 Bonds," now the "Series 2026 Bonds"); and

WHEREAS, the issuance of the Series 2026 Bonds was approved by qualified electors at a referendum held on January 16, 2024, and certified by Resolution 2024-11 adopted on such date; and

WHEREAS, the Series 2026 Bonds were validated and confirmed by final judgment of the Twelfth Judicial Circuit, Manatee County, entered on May 14, 2024, which judgment was subsequently appealed to the Supreme Court of Florida; and

WHEREAS, the Supreme Court of Florida affirmed the final judgment of validation of the Series 2026 Bonds by order of the Court on July 9, 2026; and

WHEREAS, as a result of the passage of time since the original equalization hearing on December 8, 2023, on July 17, 2026, the Board adopted Resolution 2026-20 declaring special assessments ("Series 2026 Assessments") regarding the Series 2026 Bonds in accordance with Section 170.03, Florida Statutes, adopting an updated Preliminary Assessment Roll for the Series 2026 Bonds and setting a public hearing for 9:00 a.m. on August 24, 2026, on the imposition of Series 2026 Special Assessments f; and

WHEREAS, on August 11, 2026, the Board adopted Resolution 2026-21, authorizing the issuance of the Series 2026 Bonds; and

WHEREAS, on August 24, 2026, the Board met as an equalization board and heard testimony and complaints as to the Series 2026 Special Assessments from affected property owners; and

WHEREAS, the Board then adjusted and equalized the Series 2026 Special Assessments as deemed appropriate, based on considerations of justice and right.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE UNIVERSITY PARK RECREATION DISTRICT:

1. The Whereas Clauses are hereby adopted as findings of fact.
2. Series 2026 Assessments identified in Exhibit "B" shall be adopted, except as amended, as provided in Exhibit "C" attached hereto and incorporated herein by reference ("Final Assessments"). The Final Assessments, as provided herein, shall constitute the "Final Assessment Roll" as referenced in Section 170.08, Florida Statutes. The Final Assessment Roll may be amended by resolution to reflect the construction of new homes on vacant property or lots on an annual basis and may include an appropriate adjustment to ensure the lien of the total Final Assessments shall remain at \$20,600,000.
3. A copy of the Final Assessment Roll shall be recorded by the District Manager in a special book to be known as the Improvement Lien Book held at the District Records Office and shall be legal, valid and binding first liens upon property against which Final Assessments are made until paid.
4. The Final Assessments shall be levied on all lots and lands adjoining and contiguous and bounding and abutting such improvements or specially benefitted thereby and further designated by the assessment plat hereinafter provided for.

5. There shall be on file, at the District Records Office, an assessment plat showing the areas to be assessed, with certain plans and specifications describing the purchase, construct, reconstruct, renovate, enlarge or extend, equip, acquire, operate and/or maintain recreational facilities, all of which shall be open to inspection by the public.

6. The Final Assessments shall be levied, collected and enforced pursuant to the uniform method of levy, pursuant to Section 197.3632, Florida Statutes.

7. This Resolution shall become effective upon its passage and shall be recorded in the public records of Manatee County, Florida by the District

Manager. **PASSED AND ADOPTED** this 24th day of August, 2026.

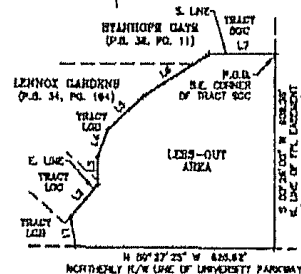
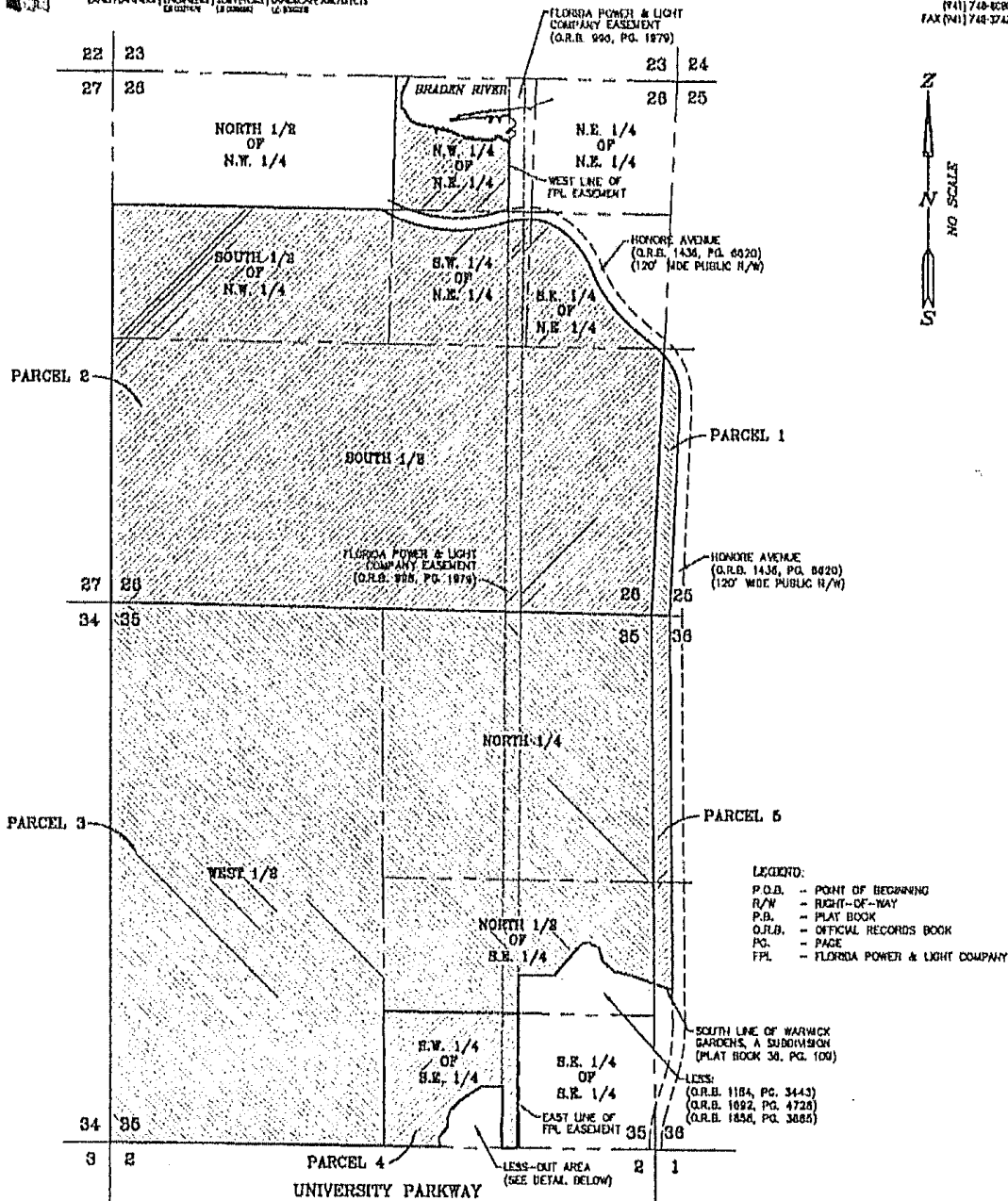
